Why UK?

The UK market always was and will be an important and desirable market and **strategic partner**.

The UK is the **largest investor** in Georgian Economy.

Georgia was one of the first countries to sign a free trade agreement and the majority of Georgian products are **free from any custom charges**.

Why Georgia?

Georgia's **liberal trade regimes** provide investors with the favourable opportunity to not only access the country's 3.7 m residents and consumers, but also the **wider region's markets**, as a direct result of the absence of customs and import tariffs. To date, Georgia has signed FTAs with CIS countries that include Ukraine, Belarus, Moldova, Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan and Turkmenistan, as well as its **neighbours**, Turkey, Azerbaijan and Armenia.

The UK-Georgia **free trade agreement** is expected to take effect from 1 January 2021.

The agreement establishes a political and economic association between the UK and Georgia, including a comprehensive free trade area.

Georgia, connecting Asia and Europe by the shortest geographic route, is also expected to ease the access of Asian investments to the European market. The liberal trade regime with the EU as well as the business climate gives the chance for this small Caucasian country to fulfill its plans to become a regional hub in the transport, logistic, energy and production sectors.



CHALLENGES! To export to the UK /Georgia you need a registered company or buyer.

! To receive the export goods in the UK/Georgia you need a registered importer with all required import licenses.

! If you do not have a buyer/importer you have to register as a UK/Georgian company, open a Bank account and employ a minimum of one administrative member of staff.

! Opening a company in the UK/Georgia is financially expensive and difficult to manage distantly.

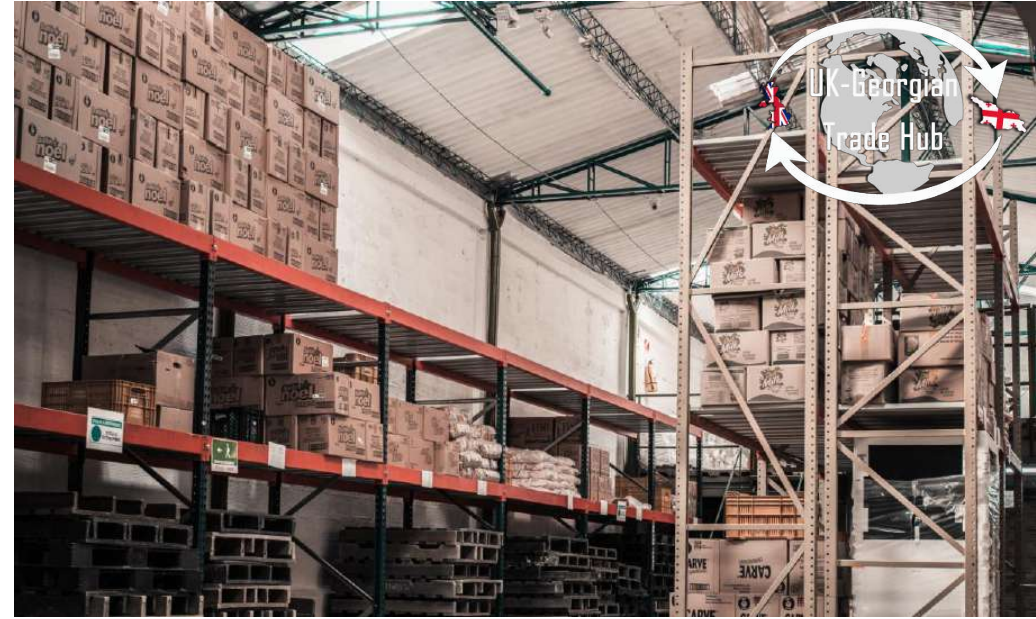

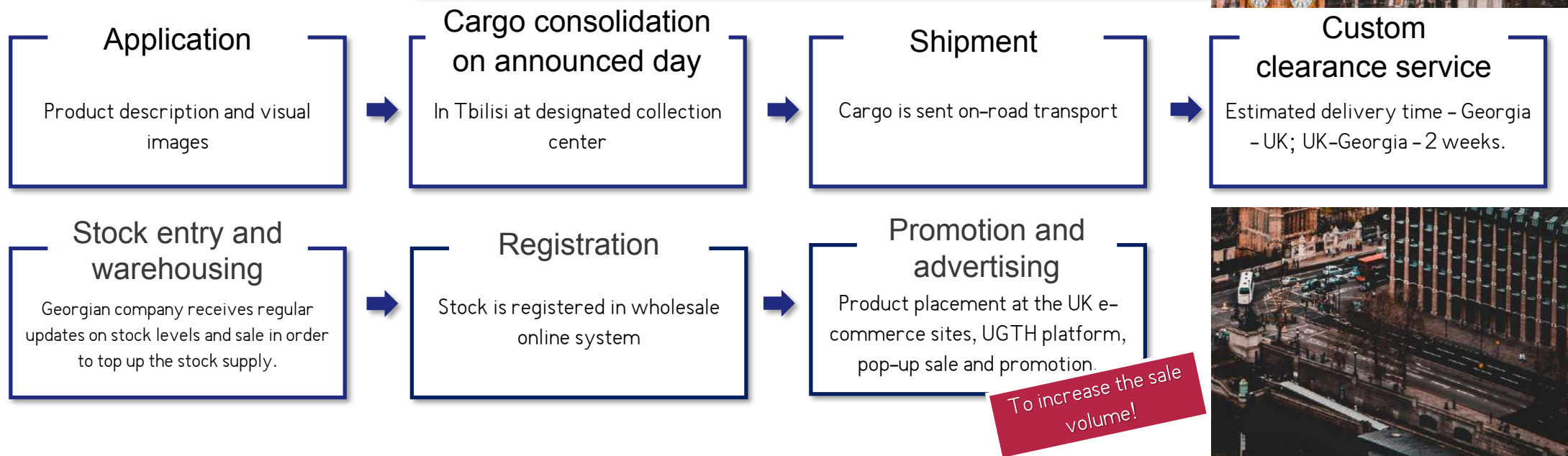

For the customs clearance and goods recipient (technically speaking importer) is UGTH- UK Ltd registered with all necessary import licensing.

On receipt of the sale notification from the Georgian producer UGTH organizes the “door to door” delivery.

PAYMENT AND FUND TRANSFER

UGTH monitors the sale and issues monthly updates on sale and dispatch.

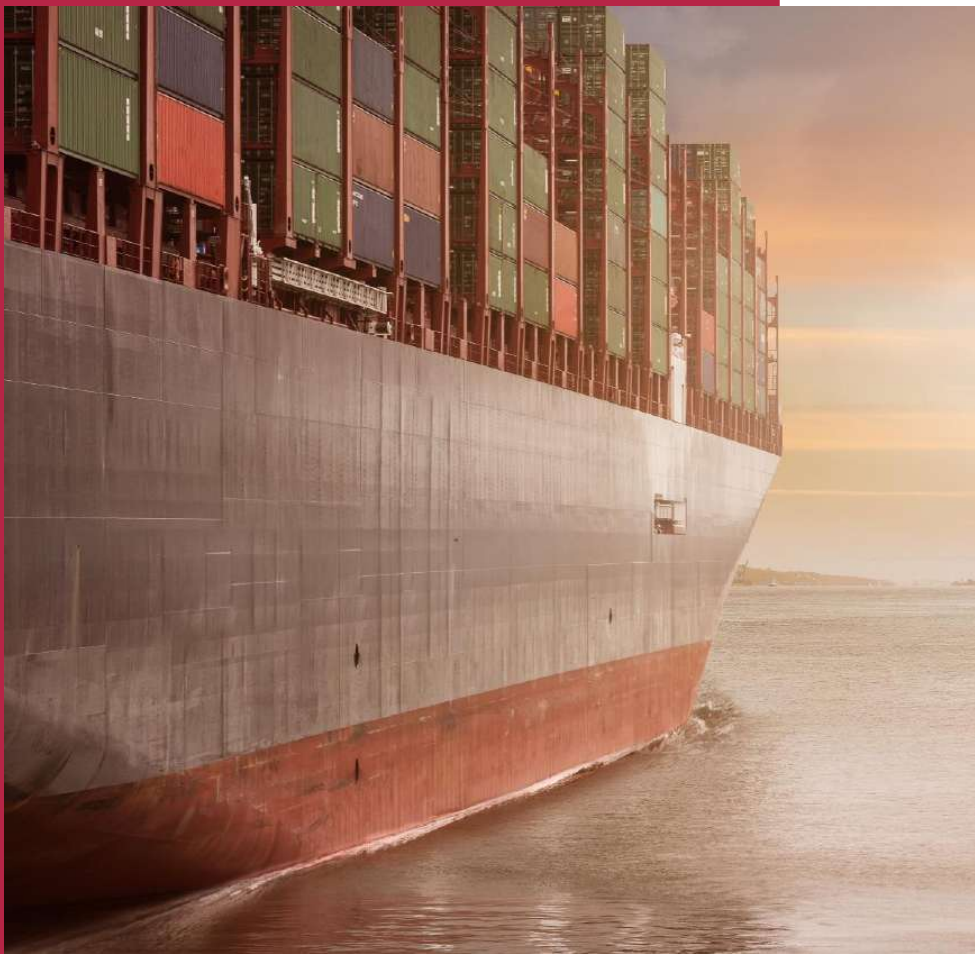
Once sold, the goods payment is sent to the Georgian producer on 30 day terms
